DE notification system – automatic system – sends out alerts – sign up on the link.

Next Item - Financials:

Financial report sound – no fees increased in 5 years.

Potential increases in 2022 is to clean retention basins, and snow removal (first year of HOA to be responsible for removal).

Dave reiterates the community is very healthy \$120k in reserves, \$75 in operating account. GVOL is in very good shape moving into 2022. Bing confers.
